FRESH APPLICATIONS FOR B.Ed & M.Ed ADMISSIONS (Academic Session 2023-24)
2nd Round of FINAL Mop-Up Counselling (OFFLINE ADMISSION)

It is for the information of all concerned that after completion of Final Mop-up-Counselling held offline on 5th & 6th December, 2023, the University of Jammu announces SECOND ROUND of Final Mop-Up Counselling for B.Ed & M.Ed Programmes. The vacant seat/s, if any, shall be filled up by the Nodal Department / Affiliated Colleges through **OFFLINE MODE** as per the following schedule and **GUIDELINES**:

1. All the candidates desirous for admission are advised to report at the concerned Nodal Department / B.Ed College along with the **Online Admission Form already filled** by them and original/photocopies of all the documents and the Affidavits as required.
2. **Eligibility & ORDER OF ADMISSION for OFFLINE Admission** will be as under:
 - a) The Candidates who have already applied for admission but were not admitted to any Campus/ Affiliated College in the first allocation round. Such applicants may edit their online application form for giving FRESH PREFERENCES for the Campus/ Colleges.
 - b) **Candidates (with CUET / Non CUET) who could not apply for admission earlier can also apply AFRESH.** Such candidates will not hold any right to claim the seats allocated to the candidates during the previous round of admission even if their merit is higher than those admitted earlier. **However, FRESH applicants have to fill online application form and have to pay requisite application fee through ONLINE MODE ONLY during the notified dates.**
3. **The Nodal Department / College shall report/accept the admissions through “MOP-UP ADMISSION REPORTING”** Icon available on the Home page of the College Login.
4. Provisional admissions shall be made purely on the basis of the Merit/ Preferences of the applicants who present themselves on the day of the counselling. Candidates failing to report for the Counselling shall not be considered for Admission.
5. **The Admission Fee for B.Ed shall be accepted through Demand Draft whereas for M.Ed the students shall report to the Nodal Department for online transfer of fee as detailed below:**

a) For B.Ed Demand Draft shall be in favour of Director, College Development Council, University of Jammu payable at Jammu while for M.Ed applicants are advised to contact Nodal Department.			
b) Any Other fee w.r.t. B.Ed College shall be directly charged by the respective College.
